Part of the structure which extends across the highway shall not exceed:

**Scaffolding must have a walkway under for pedestrians.**

You must make every effort to erect and dismantle the structure in a safe manner without creating hazard or unnecessary obstruction to the public.

Our Highways Inspector will inspect the footway again and assuming no damage is evident we will arrange for the Finance Department to forward your refund.

**THE LICENCE HOLDER SHALL: Erect the scaffolding 450mm from the kerb edge to allow pedestrians to walk underneath. Post protectors and double boarded to be in place.**

### **DESIGN OF STRUCTURE**

Ensure that the design of the structure is adequate for the purpose intended and for the period required. It must comply with all the relevant regulations and appropriate British Standards Codes of Practice. It shall be maintained in a safe condition for the period that it is in position and during the period of erection and when it is dismantled, adjusted or altered.

### **LIGHTING**

Ensure that the structure is adequately illuminated at all times between sunset and sunrise. This lighting is to be provided by amber coloured bulkhead type electric lamps. In the event of a mains electricity supply not being available, battery powered amber lamps will be affixed to the structure. All lamps will be positioned 2.13 metres above the level of the highway at each corner and intermediately at 4.0 metre centres.

### **TEMPORARY PEDESTRIAN ACCESS**

Ensure that when the footway is reduced in width by the structure to less than 0.9 metres, a temporary walkway is to be formed, if necessary, in the carriageway. This will be not less than 1.0 metre in width and must be so placed that there is clear pedestrian access around the structure, at all times. Where required, approach ramps, with appropriate slopes will be constructed to provide ease of access for perambulators, pushchairs and pedestrian controlled vehicles. In all cases handrails will be provided to ensure that where the walkway passes through the structure, it shall be not less than 1.0 metre wide and that the headroom is at least 2.45 metres above foot level. The walkway will be boarded and protected from the working areas and adequate lighting will be provided.

### **DISPLAY OF NOTICE**

Ensure that the notice supplied by the Council, giving details of the Licence, is displayed in a convenient place on the structure, in such a way as it may be easily read by any interested party.
